The initial post must contain at least two academic references. Students will then respond to at least two other student posts with 150–250 word academic responses containing at least one academic reference. Both initial posts and responses should be scholarly in nature. Responses should utilize critical thinking and be both analytical and positive. Initial posts are due by 11:59 pm on Thursday and response posts are due by 11:59 pm on Sunday.	20 pts for each lesson (60 pts total)
Reading Synthesis Part 1	Reading assignment for each session	Reading Response (RR). The student will find five (5) major concepts from each reading assignment. The student will then support each of the major concepts with five (5) supporting arguments. The RRs should be direct quotes and contain no personal opinion or evaluation. Use parenthetical citations for each point and sub-point. RRs are due by Friday at 11:59 pm each week.	RR 20 pts each (140 total pts)

Reading Synthesis Part 2	Ross 8/31 Cosper 9/12 Lim/Ruth 9/26 9/5	Using all of the RR points created from part one, the student will write a summary of each text. The summary should discuss the author's thesis and supporting arguments as well as the major themes discovered in the RRs. Critical thinking and analytical skills should be employed as the student synthesizes and evaluates the author's work. Summary length for each text should be 1,000–2,000 words. Personal Theology and Practice of Worship Paper		personal theology and practice of worship. The paper must include at least 5 footnoted sources including those used in course discussion and reading. Paper should be in Turabian format and include a title page and bibliography. The paper should be 1,500–2,000 words in length.	250 μις
Worship History Timeline	9/14	Using reading and other sources, students will create a timeline from Creation (4,000 BCE) until the present day. The timeline needs to be in 10-year increments, and include significant events, eras, and people during each time period. Use a spreadsheet (e.g. MS Excel, Apple Numbers, or Google Sheets) to create your timeline. Examples will be discussed in the introductory session.	200 pts
Worship Observation	9/19	Students will attend a worship service from a Christian tradition that differs from their worship background. Prepare a 700–900 word response for the worship service. Include comments and questions regarding biblical, theological, and liturgical concepts. Indicate, in your opinion, the theological strengths and weaknesses of the service planning and execution. The paper should follow Turabian format and include a title page and bibliography with at least three references. Special note: attend the service as an active participant not a liturgical tourist.	200 pts
Song Evaluation	#1-8/17 #2-8/29	Students will theologically evaluate two (2) songs chosen from a list of songs posted on Blackboard. Song choices must be emailed to the instructor and will be selected on a first-to-email basis. Evaluations will be posted to the course blog on medium.com. See description in Blackboard for details and links to the blog. Elements to be included in your evaluation blog post: author/composer information, biblical basis, textual analysis of each portion (e.g. verse/stanza, chorus, bridge, etc.), musical evaluation, and an evaluation of its use in corporate worship.	50 pts each post (100 pts total)

Final Paper	Prospectus 8/24 Final Paper 10/1	Students will write a 2,500—3,500 word final paper on some aspect of corporate worship. The paper should be in Turabian format and must cite 15—20 academic resources utilizing both books and journal articles. The topic must be presented in a paper prospectus due by 11:59 pm on 8/24. The prospectus should include a working title, thesis statement, outline, and proposed bibliography. After the topic is approved, the student may work to complete the paper due by 11:59 pm on 10/1.	400 pts
Worship Service Planning Series	9/21	Students will plan a three-week series of worship services. Service plans must include all elements of a weekend service: music, spoken portions, sermon title and text. The two ordinances of the church—baptism and Lord's Supper—must also be included in at least one of the services. The student must demonstrate an understanding of the elements of a worship service and the ability to develop a worship service plan with meaning and purpose following the models discussed in the sessions.	200 pts
